SECTION 4: FIRST AID MEASURES

4.1 Description of First Aid Measures

Eye: Flush eyes with water for several minutes. Remove contact lenses, if present and easy to do so. If eye irritation persists, get medical attention.

Skin: Wash skin with soap and water. Remove clothing and shoes if contaminated. Launder clothing before reuse. If irritation or rash develops, get medical attention.

4.2 Most Important symptoms and effects, both acute and delayed: May cause mild eye irritation. Prolonged skin contact may cause irritation. Inhalation of vapours or mists may cause respiratory irritation. Swallowing may cause gastrointestinal irritation, nausea, vomiting and diarrhoea.

4.3 Indication of any immediate medical attention and special treatment needed: As a general rule, and in all cases of doubt or when symptoms persist, always seek medical attention. Never give anything by mouth to an unconscious person.

5.1 Extinguishing Media Use foam, dry chemical or carbon dioxide (CO2) to extinguish flames. A solid stream of water or foam can cause frothing.

SECTION 6: ACCIDENTAL RELEASE MEASURES

6.1 Personal Precautions, Protective Equipment and Emergency Procedures:

6.2 Environmental Precautions:

Avoid release into the environment. Report spill as required by local and national regulations.

6.3 Methods and Material for Containment and Cleaning Up:

Dike spill and collect with an inert absorbent. Place into closable containers for disposal. Collected material is handled in accordance with section 13 "Disposal Considerations".

SECTION 7: HANDLING AND STORAGE

7.1 Precautions for Safe Handling: Avoid contact with eyes, skin and clothing. Avoid breathing vapours and mists. Wash thoroughly with soap and water after handling. Remove soaked clothing and launder before re-use.

7.2 Conditions for Safe Storage, Including any Incompatibilities: Store in a cool area away from oxidising agents. Protect containers from physical damage. Brake fluids absorb water from the atmosphere – always keep containers tightly closed.

7.3 Specific end use(s): The product is to be used as a brake fluid. Prolonged contact with the skin should be prevented due to the risk of skin dryness and cracking. If inhalation of high concentrations of vapours and mists cannot be prevented appropriate personal protective equipment should be used.

8.2 Exposure Controls:

Appropriate Engineering Controls: Use with adequate local exhaust ventilation to minimize exposure. Use explosion proof equipment where required.

Respiratory Protection: If the exposure is excessive or irritation is experienced, an approved particulate/organic vapour respirator appropriate for the form and concentration of the contaminants should be used. Selection and use of respiratory equipment must be in accordance with local regulations and good industrial hygiene practice.

Skin Protection: Wear impervious gloves in accordance with EN 374 to avoid skin contact. Protective clothing if needed to avoid skin contact and contamination of personal clothing. Suitable washing should be available in the work area. Contaminated clothing should be removed and laundered before re-use.

Potential Health Effects:

Eye Contact: May cause mild irritation.

Skin Contact: Prolonged or repeated contact may cause mild irritation or dryness. Repeated skin contact may cause non-allergic dermatitis.

Inhalation: Excessive inhalation of vapours or mists may cause upper respiratory tract irritation. **Ingestion:** Swallowing large amounts may cause gastrointestinal effects including nausea and diarrhoea.
